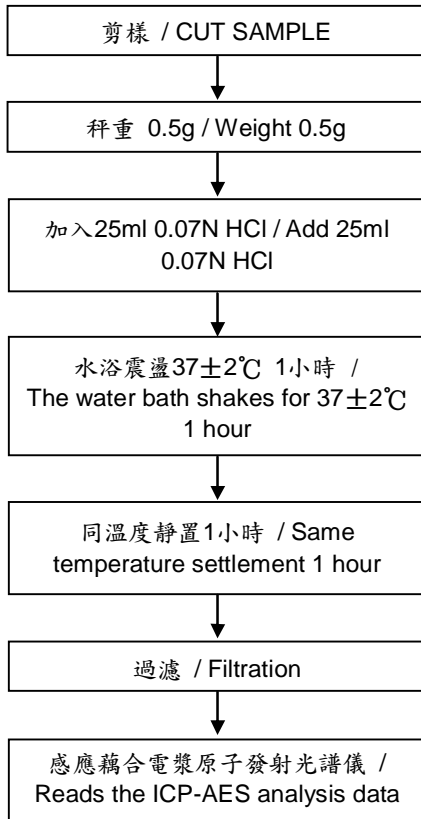

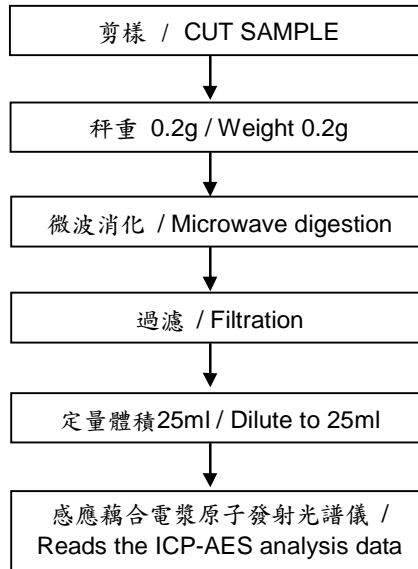
ASTM F963-08 分析流程圖 / ASTM F963-08 Analytical flow chart
